

## Factorial chooses its new corporate headquarters in Barcelona in a Colonial building and reinforces its commitment to innovation

Now, with more than 1,000 people in the team and an accelerated international expansion, the company has established itself as an international benchmark in the sector, which has led to the need for a larger space adapted to its growth rate. Until now, its activity was distributed in several buildings located in the same area of the city.

"At Factorial we are in a unique moment, we are growing at an unstoppable pace, incorporating more than 40 people into the team every week. In these times of rapid growth, culture is more important than ever, which is why it was key to bring the whole team together in one place," said Jordi Romero, CEO of Factorial.

The new building, owned by Colonial, has been selected after an exhaustive search process led by BNP Paribas Real Estate. Located in the heart of the 22@ district, in the area known as Eix Llacuna, the 'Illacuna' complex has been recently refurbished and has a total area of 20,500 sqm, divided into three office buildings. Factorial will occupy the entire C building (5,600 sqm) and two floors of building A (2,400 sqm). The property is fully occupied.

"Illacuna is a 'prime Asset Class' product that fits in with Factorial's commitment to innovation and is based on a 'Triple E' (Experience, Environmental, Efficiency) model, consisting of offering quality, transparent, and efficient spaces, which promote experiences for their tenants and have the highest standards in terms of sustainability" said Albert Alcober, business director of Colonial.

Illacuna is located in one of the most sought-after areas of the district, in a central environment and close to shops, shops and other services, and also has the BREEAM environmental seal. Factorial, therefore, will locate its headquarters in a prime office building, a segment within the office market that Colonial leads in Europe.

The operation is one of the most important in the Barcelona office market in terms of size and impact. The real estate consultancy BNP Paribas RE has advised on the search for the location for the new

headquarters. According to data from BNP Paribas RE, the dynamism of Barcelona's office market is unstoppable, with a growth in leasing of almost 15% in 2024. In addition, the 22@ district has concentrated 34% of the operations closed in the last quarter.
